OTHER TRANSACTION COSTS

Each Fund's estimated other transaction costs are set out in the table below. The figures are calculated as a percentage of the average fund size and are estimated based on a reasonable estimate of the last financial year, apart from recently established funds, which are a reasonable estimate of the transaction costs for the current financial year. You can determine the dollar value of these costs over a 1 year period by multiplying the transaction cost rate with your average account balance. For example, the value of other transaction costs on an average account balance of \$50,000 invested in the Ausbil MicroCap Fund is \$330.
