# Ausbil Active Dividend Income Fund - Wholesale Class (ARSN 621 670 120, APIR AAP3656AU) (Fund)

This Notice to Unitholders updates the Product Disclosure Statement (**PDS**) issued by Ausbil Investment Management Limited (ABN 26 076 316 473 AFSL 229722) (**Responsible Entity**, **Ausbil**, **Ausbil Investment Management**, **we**), as responsible entity of the Fund, and dated 30 September 2023.
