The performance fees shown in the table below are based on the performance fees incurred for the financial year ending 30 June 2023. If no figure is shown, the Fund does not charge performance fees.

#### **TRANSACTION COSTS**

Transaction costs are the costs incurred when assets are bought or sold by the relevant Fund, such as brokerage, settlement costs and clearing costs. Transaction costs are reflected in each Fund's unit price. As these costs are factored into the value of each Fund's assets and reflected in the unit price, they are an additional cost to you (where they are not recovered by the buy-sell spread).

The relevant Fund's estimated transaction costs are set out in the table below. The figures are calculated as a percentage of the Fund NAV estimated based on the financial year ending 30 June 2023. Each Fund's estimated and/or historical transaction costs may not be an accurate indicator of the actual transaction costs you may incur in the future.

You can determine the dollar value of these costs over a 1 year period by multiplying the net transaction cost figure with your average account balance. For example, the value of net transaction costs on an average account balance of \$50,000 invested in the Ausbil MicroCap Fund is \$45.
