Ausbil Global SmallCap Fund (ARSN 623 619 625, APIR AAP8285AU, ASX:GSCF) (Fund)

This Notice to Unitholders updates the Product Disclosure Statement (**PDS**) issued by Ausbil Investment Management Limited (ABN 26 076 316 473 AFSL 229722) (**Responsible Entity, Ausbil, Ausbil Investment Management, we**), as responsible entity of the Fund, and dated 13 October 2025.

In particular, this notice updates the Fund's fees and costs disclosure in the PDS.

Please review this notice alongside the PDS and the Target Market Determination (**TMD**), as well as any updates to these documents and information incorporated by reference. You can access this notice, the PDS and the TMD and other related information online at www.ausbil.com.au.

The performance fee may be higher. The Fund's performance fee for the 5 years to 30 June 2026 ranged from 0.00% to 1.70% pa. It is not possible to disclose the actual performance fee payable in any given period, as we cannot forecast what the performance of the Fund will be.
