Ausbil High Conviction Equity Fund (ARSN 622 627 696, APIR AAP9227AU) (Fund)

This Notice to Unitholders updates the Product Disclosure Statement (**PDS**) issued by Ausbil Investment Management Limited (ABN 26 076 316 473 AFSL 229722) (**Responsible Entity, Ausbil, Ausbil Investment Management, we**), as responsible entity of the Fund, and dated 30 September 2023.

1. Update to the name of the Fund

This notice updates the name of the Fund to the **Ausbil High Conviction Equity Fund**. All references to the Ausbil Australian Concentrated Equity Fund in the PDS and AIG are replaced with the Ausbil High Conviction Equity Fund.

2. Update to the Fund's fees and costs disclosure

This notice updates the Fund's fees and costs disclosure in the PDS and the Additional Information Guide (**AIG**), as outlined in the following pages.
