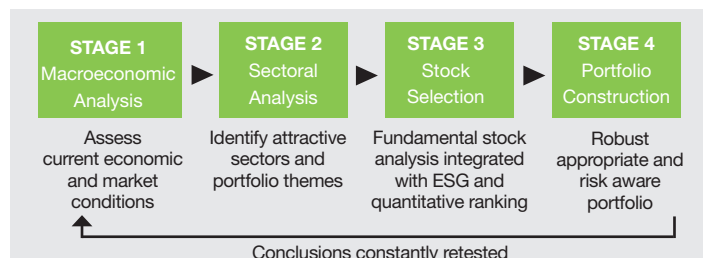
- Invest in 30-40 quality mid to small cap Australian companies

Investment style
